



## MSU Departmental Required Drug Screening

Healthcare accreditation organizations mandate that hospitals and other health care agencies require students who participate in the care of patients to be subject to the same standards as their employees. Accordingly, submitting a negative urine drug screen is a condition for participation in the clinical components, based on the policies of the Imaging Science Departments. Counseling and Health Services Clinic (C&HS) will serve as the collection facility, with specimens tested through the Quest Diagnostic Lab Service. Should a student be enrolled in on-line courses and live off-site of MSU, Quest Lab collection facilities have been determined and processes put in place so that these students may perform their urine drug testing closer to their home. Nursing and Imaging Science faculty and staff will notify students as to when drug testing is to be completed. The incurred cost will be \$35.00, of which the student will be responsible for paying to C&HS at the time of service. Third-party insurance will not be billed for drug screen services. Prices may differ depending if student is using an off-site collection facility. Consent will be obtained through the compliance release of information form for the specific departments or specific individual identified by the patient. The collection process will follow the non-DOT regulations, by collectors trained through Quest Lab services. Results will be reviewed by providers of C&HS. Test results are confidential with disclosure of results provided electronically or in writing, only to approved persons involved in evaluating qualifications for clinical programs. Disciplinary actions against students, with regard to urine drug screen results, will be at the discretion of the specified departments and University administration. Mandatory reporting requirements found in KRS 314.031 require a positive result of an individual with a professional Kentucky nursing license be reported to Kentucky Board of Nursing KARE program. This meets the legal reporting requirement for purposes of the Health Professionals Recovery Program (HPRP).

**YOUR DEPARTMENT-and/or MSU C&HS WILL PROVIDE INSTRUCTIONS REGARDING WHEN THE RANDOM DRUG SCREENS WILL OCCUR.** Please watch your MSU email account for any messages that may apply to your random drug screen.

### **BEFORE YOUR TEST**

Payment to Counseling and Health Services is required prior to collection of drug screen specimen.

#### **IF YOU CHOOSE TO GO TO AN APPROVED OFF-CAMPUS COLLECTION SITE**

- Call C & HS 606-783-2055 to pay \$35.00 by phone with credit or debit card
- Identify your name and MSU student ID number, email, as well as the site you will go to for your urine drug screen test. Please also identify the school/department you are a part of.
- Once payment is received, you will receive an order by email that **YOU MUST TAKE WITH YOU ON THE DAY OF YOUR TEST. THE EMAIL CONFIRMATION WILL LIST AN ORDER EXPIRATION DATE –THE TEST MUST BE COMPLETED PRIOR TO THIS DATE AND TIME**
